FACTS

This case has been resolved as to all Defendants. An Order of Default was entered by the Court on December 5, 2005, against AvTech Direct. A Stipulated Permanent Injunction as to MD&I Corporation and Min Hui Zhao, and an Order of Dismissal of All Claims Against MD&I Corporation and Min Hui Zhao were entered by the Court on February 27, 2006, and March 1, 2006, respectively. A Stipulated Judgment as to Arlene Grant a/k/a Sediqizad was entered by the Court on March 22, 2006. An Order Granting Plaintiff's Motion for Summary Judgment against Gary Hunziker was entered by the Court on May 19, 2006.

CONCLUSION

Because the case has been resolved as to all Defendants, Plaintiff respectfully requests that the Court enter an Order Dismissing the Case and Striking the Trial Date.
